Health Assessments and Opportunity for Collaboration



Hospitals & Health System- HealthPartners

- Community Health Needs Assessment (CHNA)
- Tool for hospitals to meet their mission
- Identify the needs of the community and direct community benefit activities toward those needs
- Required every three years by IRS as part of the Affordable Care Act

Coordinated with:

- All HealthPartners Hospitals
- Valley Hospitals aligned effort
- Boards of directors



Local Health Department-Washington County

- Community Health Assessment (CHA)
- Foundational activity to set priorities, develop programs, seek funding, and maintain policies
- Understand the health of the population, identify contributing factors and community assets
- Required every five years by state law since 2003 (Local Public Health Act, *MN Statutes 145 A.10, Subd. 5a*)
- Requires development of Community Health Improvement Plan (CHIP)
- Required for Accredited status under Public Health Accreditation Board (PHAB) standards

Coordinated with:

- Washington County Board of Commissions

Why Collaborate?

- Shared geographic area
- Long collaboration history
- Trust and mutual respect
- Similarities between CHA and CHNA
- CCH/East metro CCH (indicators, collaborations)
- Greater range of expertise and perspectives




Potential roadblocks

- State and geographic differences
- Timeline
- Requirements
- Approval processes (6 BOD and County Commissioners)
- Other leader input
- Less complex to do within an organization, than with two
- Data sharing limits
- Staff changes
- Other collaboration commitments

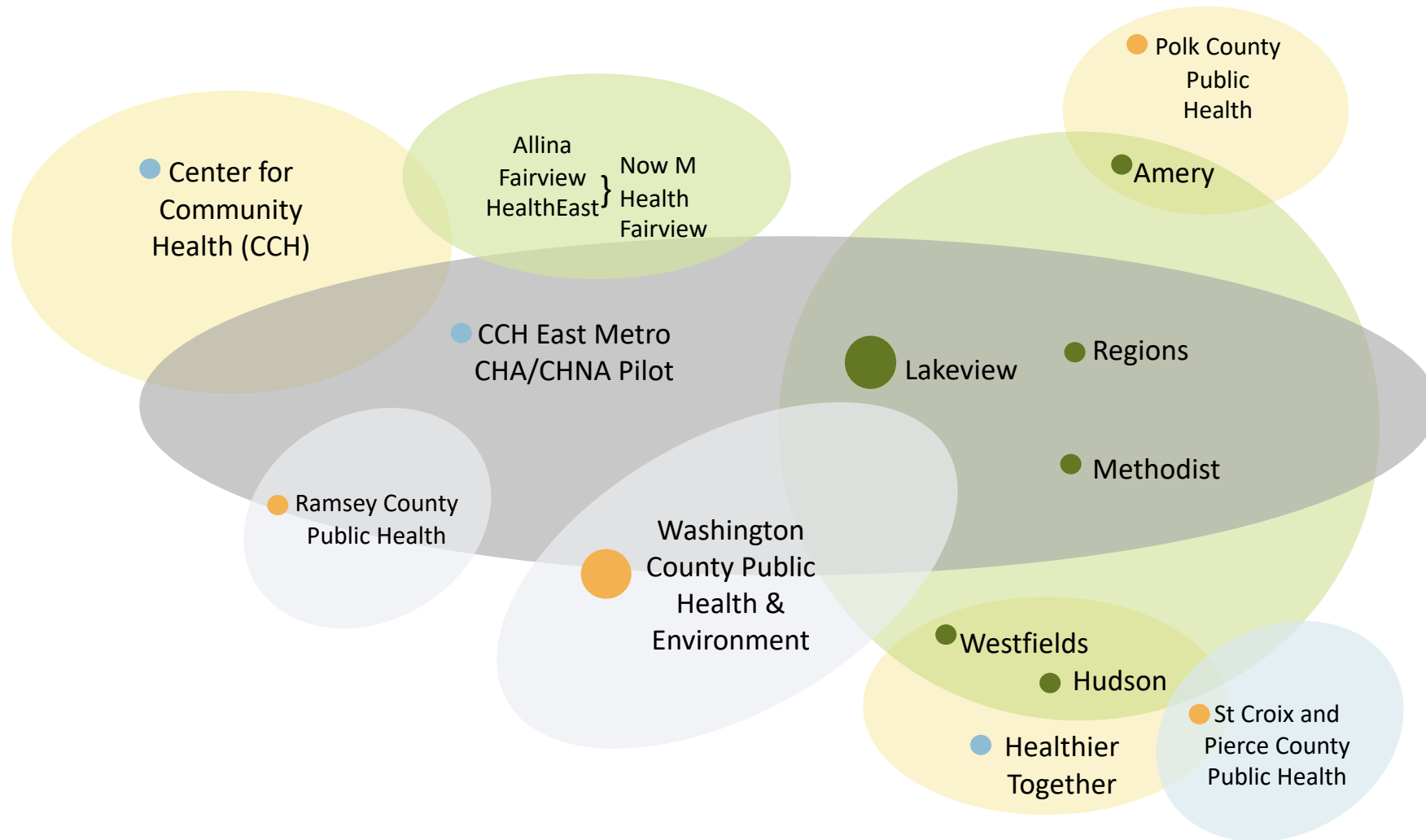

- Share data

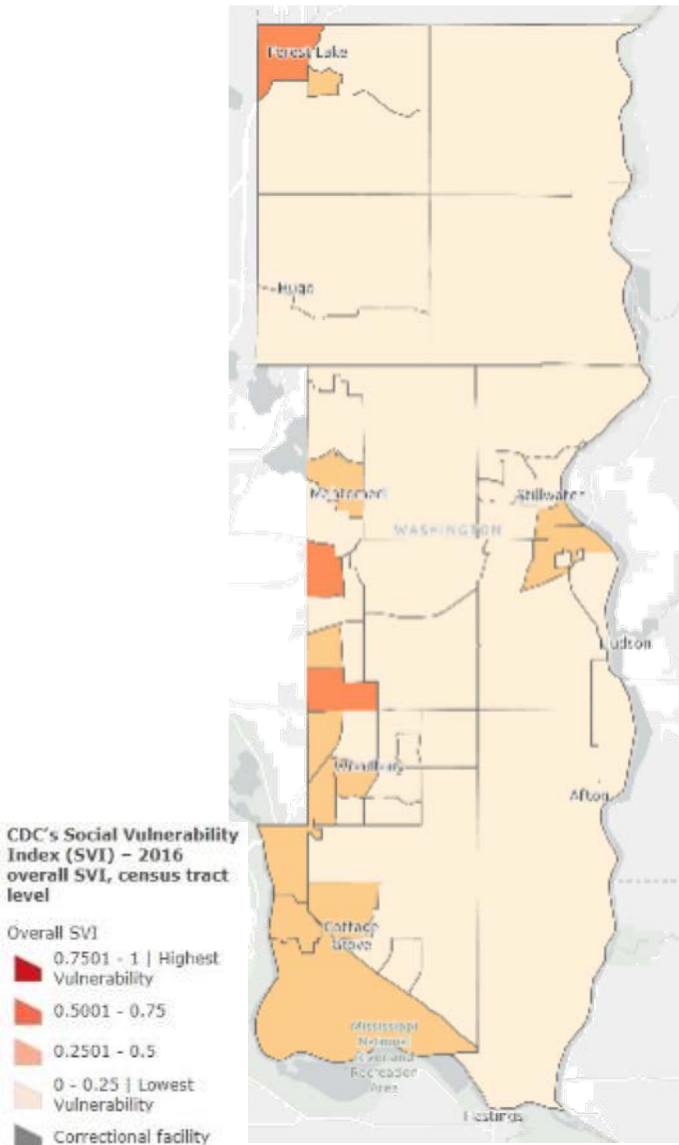
How are certain populations disproportionately impacted and how can we partner with these communities to address needs and eliminate disparities?

Health Equity



Poverty can create multiple barriers for residents including:

- Access to healthy foods
- Access to care
- Educational opportunities
- Neighborhood safety
- Health rates for low income populations to provide a better picture of health for all residents in Washington County.



Priority: Access to care

Access to care refers to having appropriate, convenient and affordable health care. Includes: proximity to care, cost, insurance coverage, cultural sensitivity and responsiveness.

Priority: Access to Health

Access to health refers to the social and environmental conditions that directly and indirectly affect people's health such as housing, income, employment, education, and more.

Transportation is a bridge to access!



Transportation scorecard



All residents have opportunity to attain their full health potential.

R

Residents have improved mobility and transportation options that link them with a variety of health services and opportunities to be healthy.

P

Develop a one stop for transportation information and referral.

P

Increase awareness of the One-Stop and of existing transportation options through high quality training and outreach events

P

Provide twenty high-quality travel orientation events that supports greater mobility for persons with disabilities and older adults

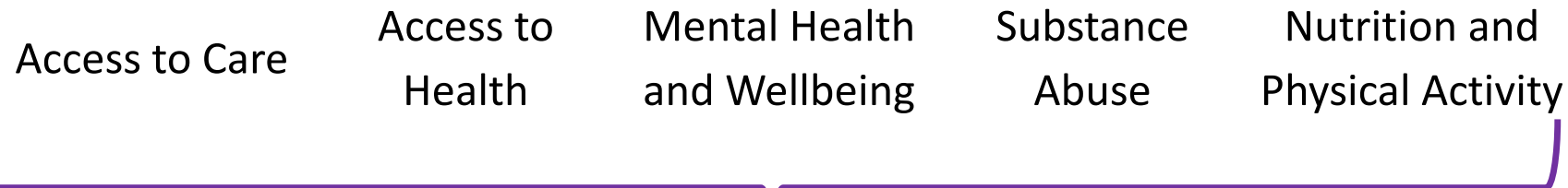
P

Sustain the involvement of both external and internal partners in increasing awareness and improving opportunities for mobility for those who cannot, do not, or opt not to drive

P

Advocate and promote long-term investments in transit to provide reliable and efficient transit services.

- Opioid Collection-Lead

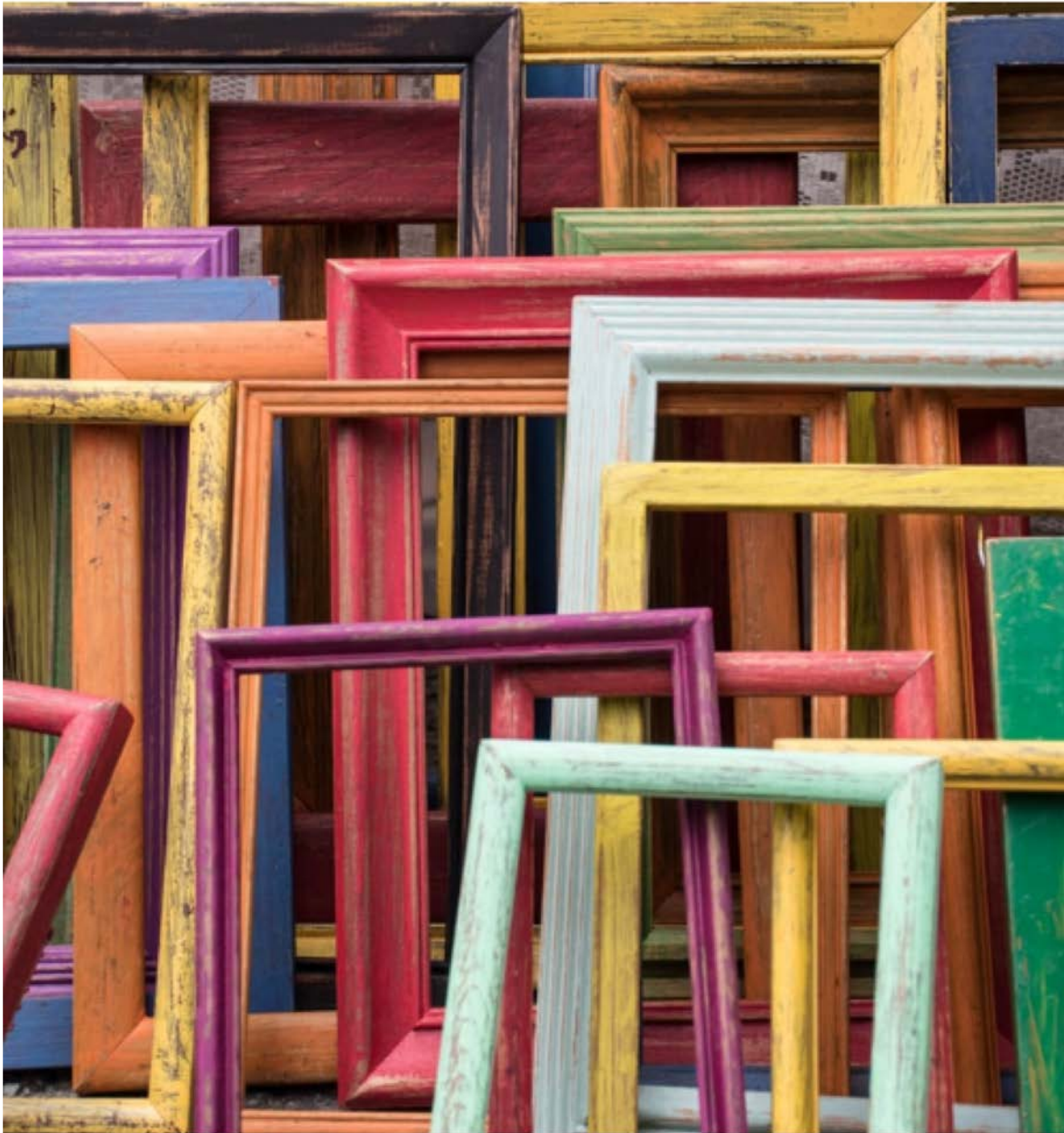

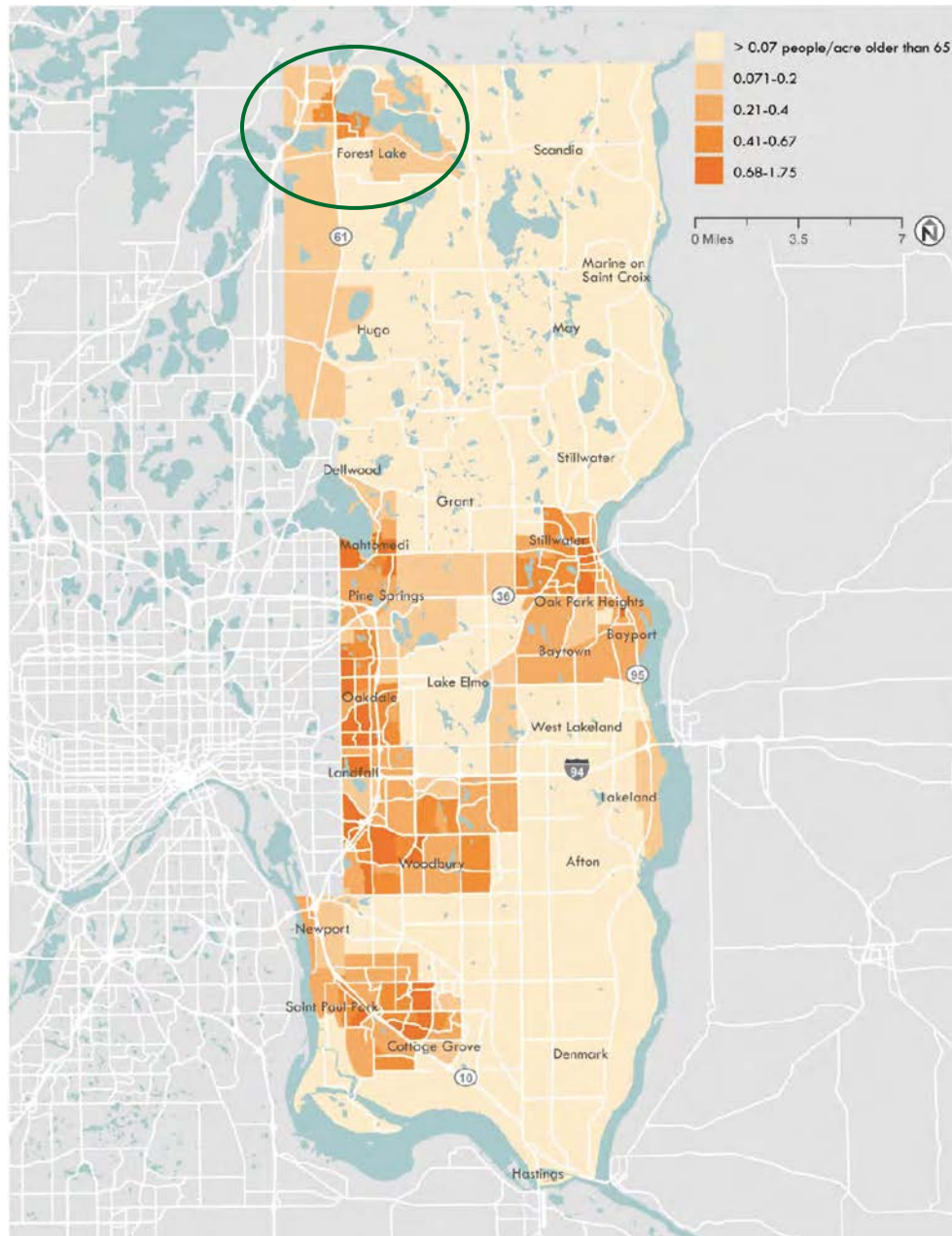

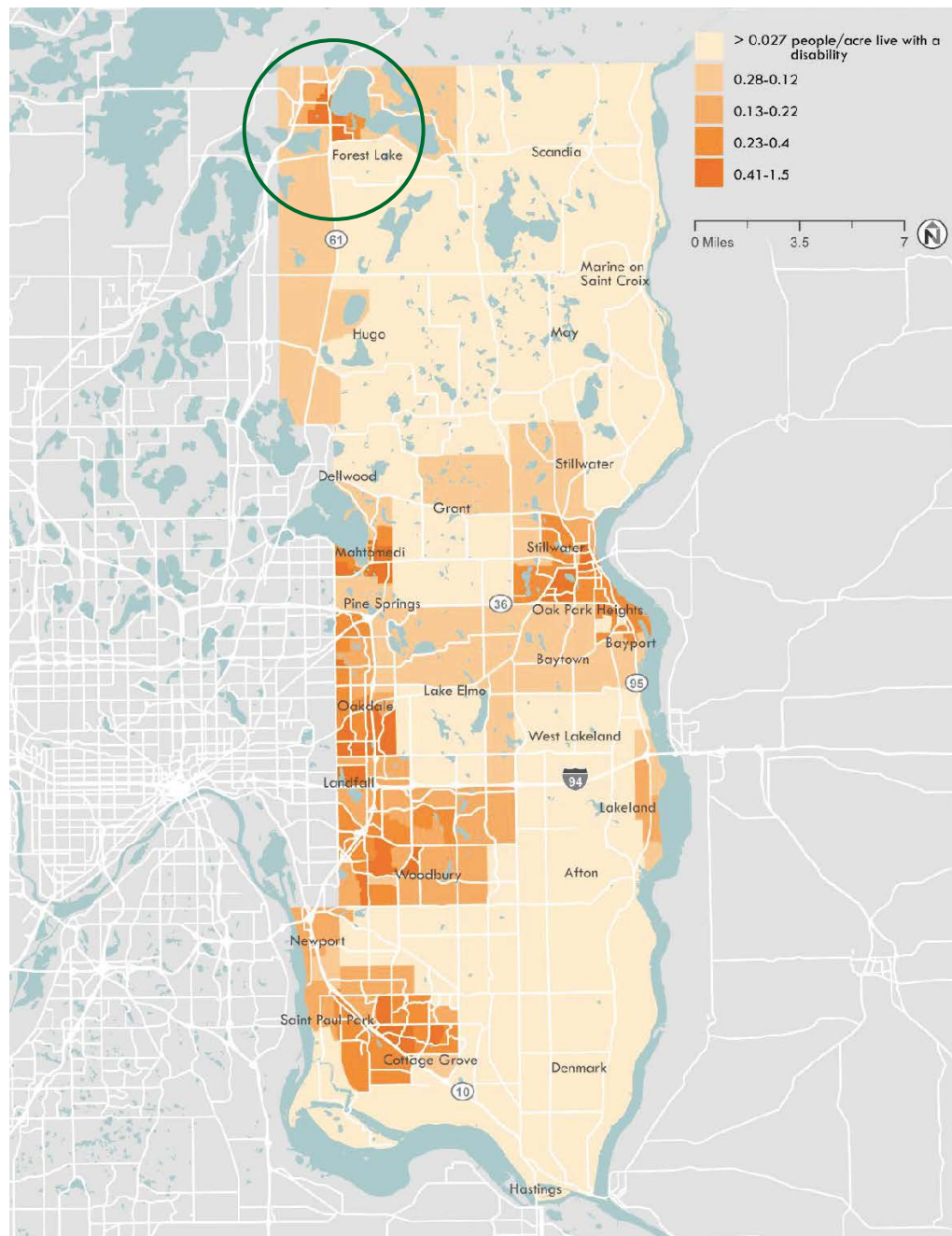


Visual Tour of Residents That Call Washington County Home

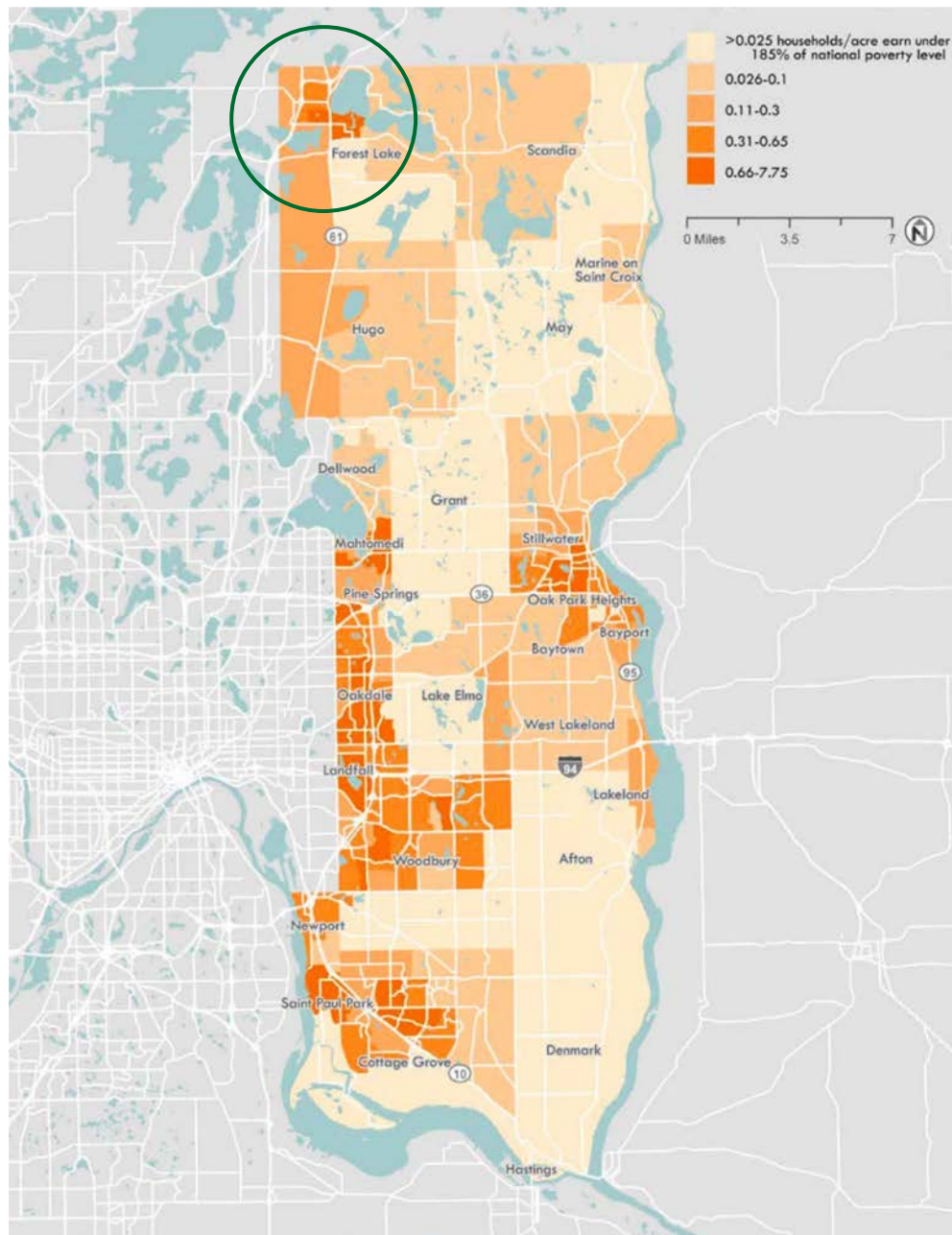




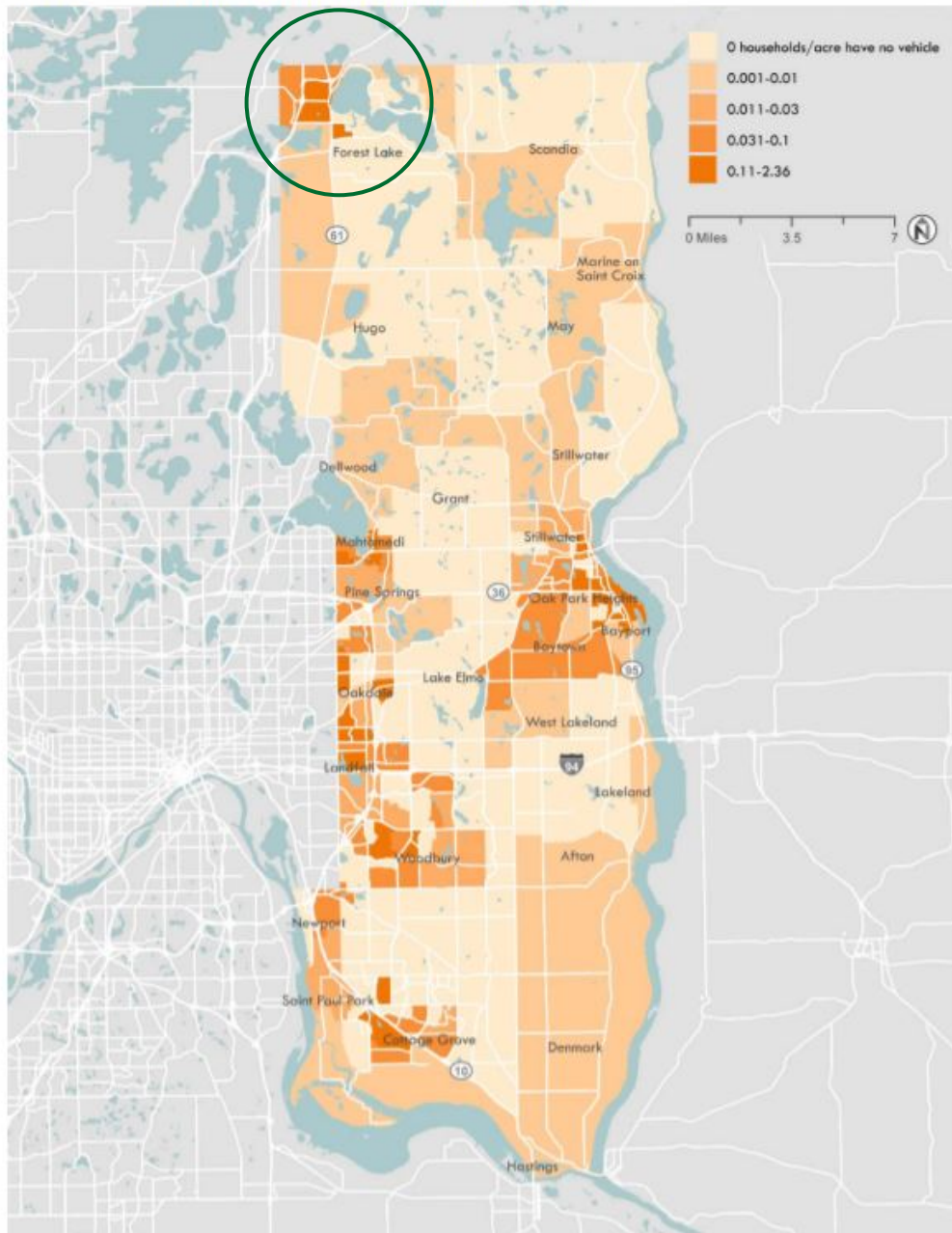
Washington County: Older Adults



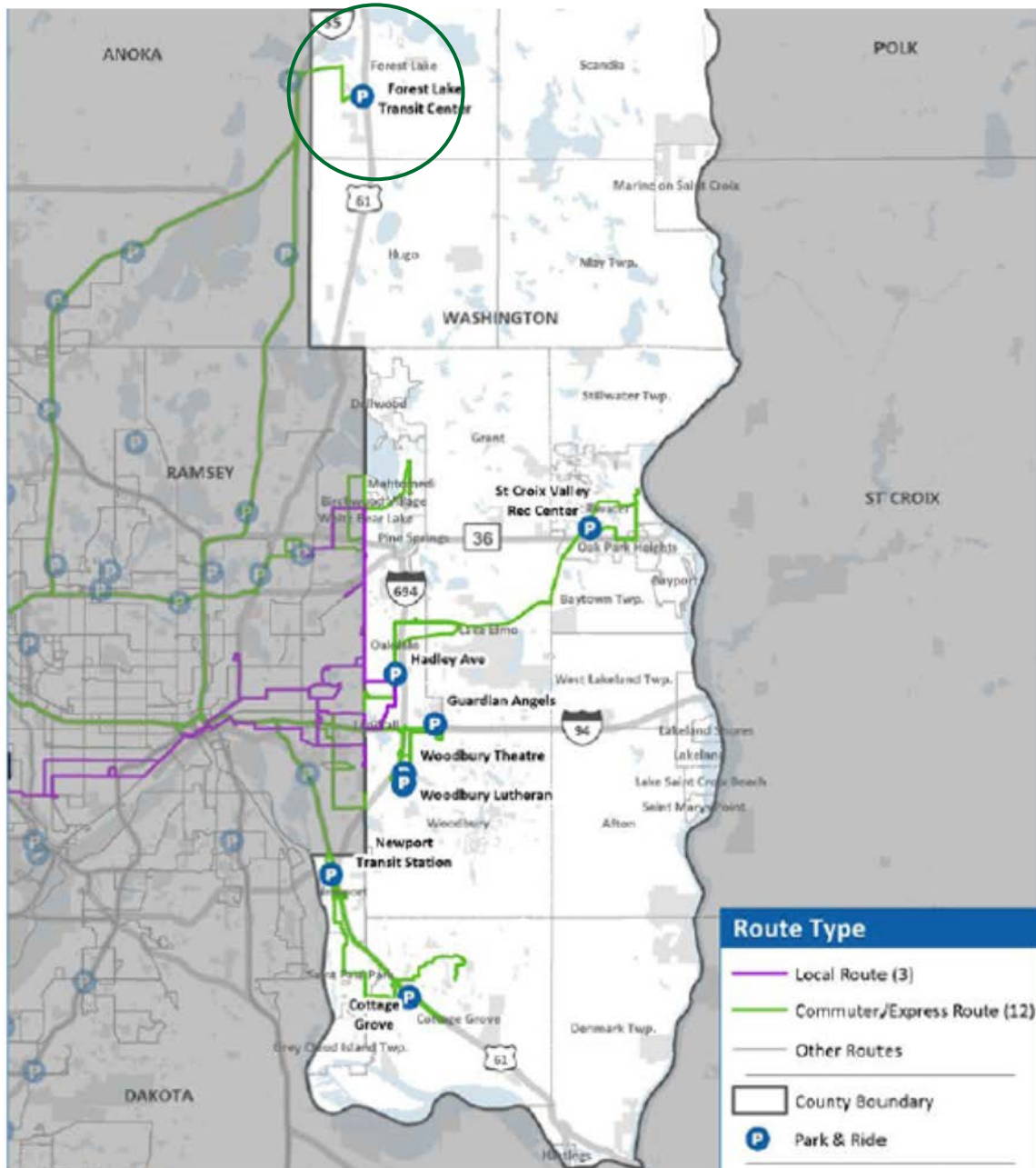
Washington County: Persons with Disabilities



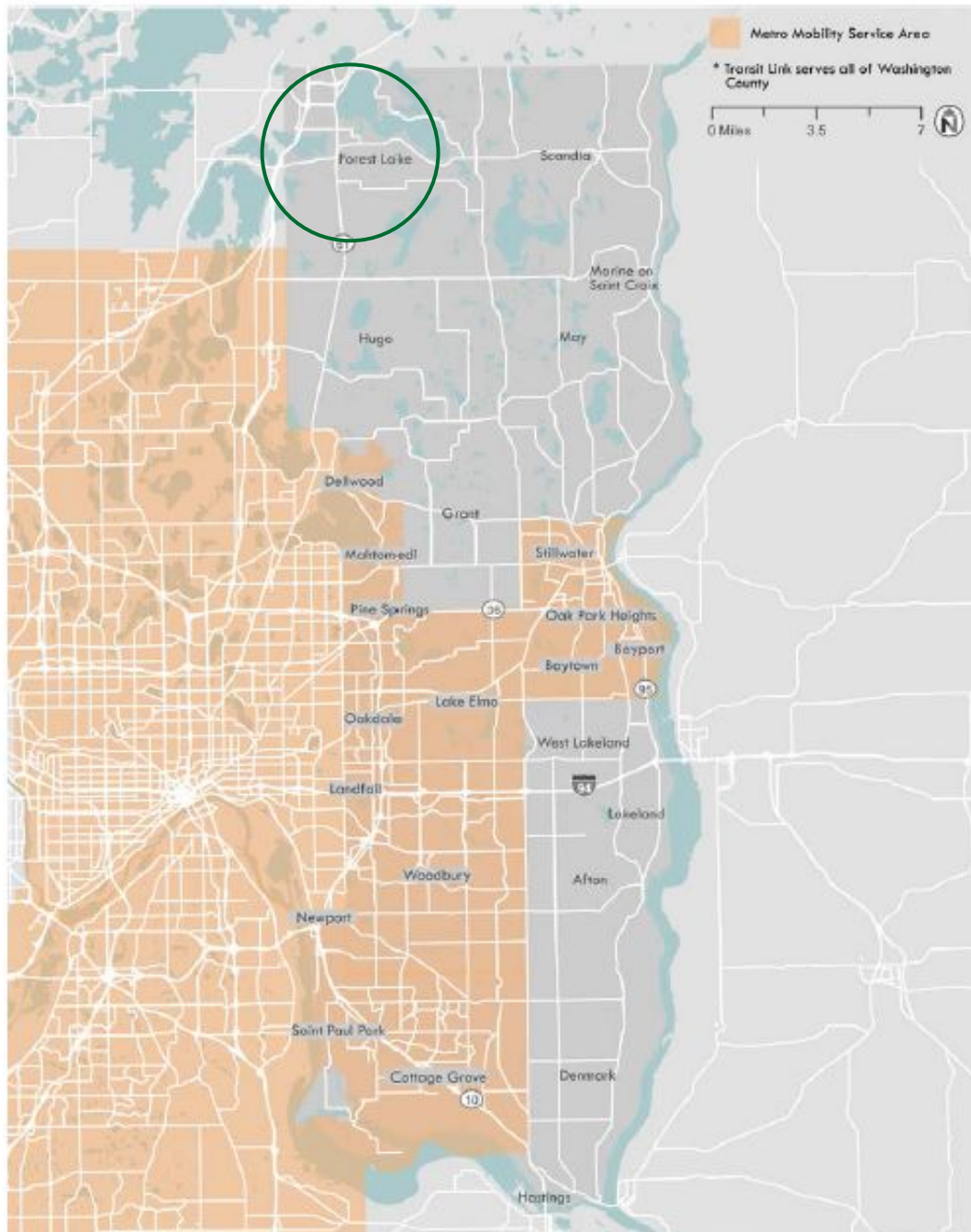
Washington County: Individuals Living With Low Incomes

Transit Link

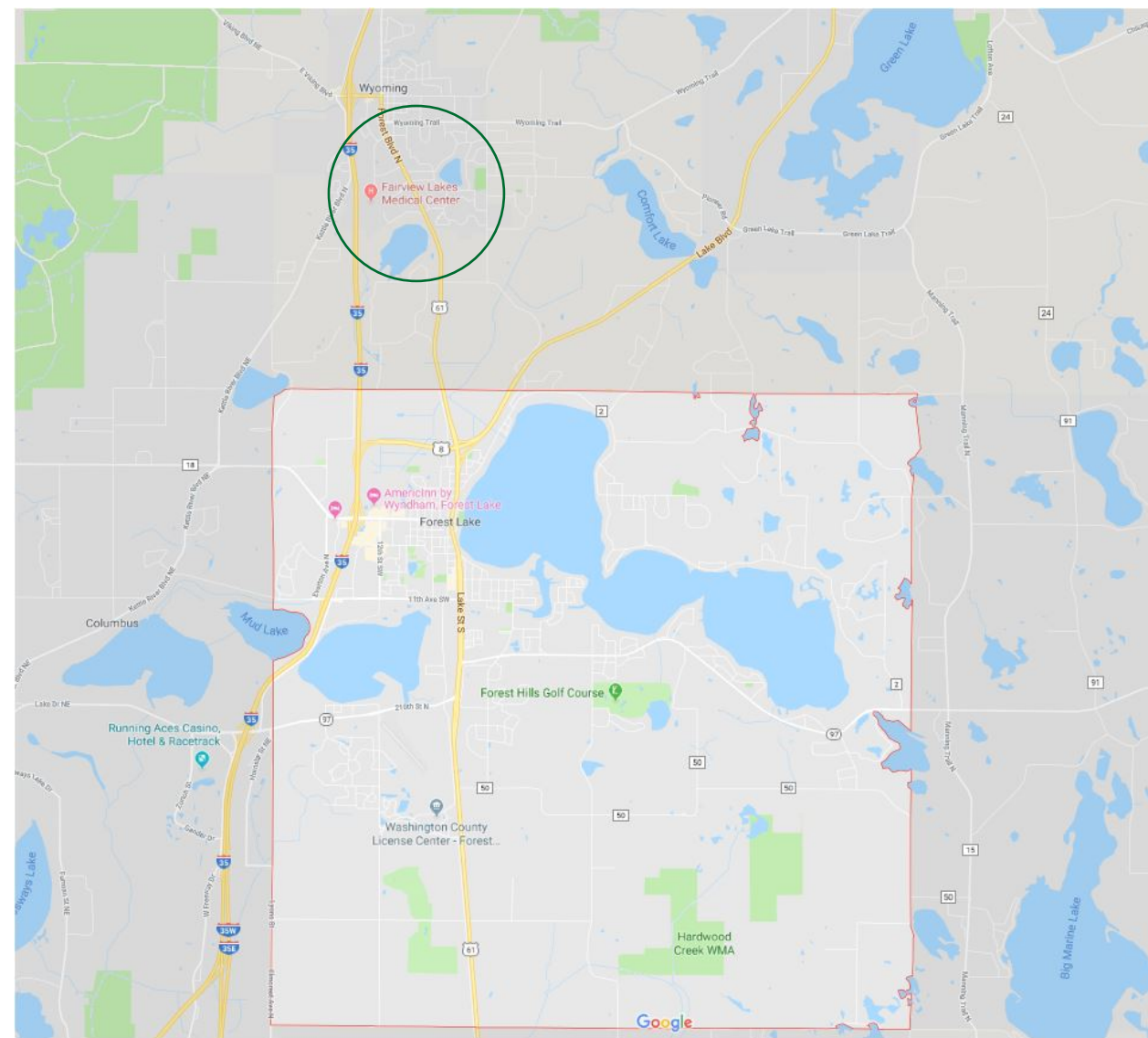
- Operated by Metropolitan Council via 3 contractors
- Eligibility: Any one in Washington County.
- Hours of service: Monday- Friday, 6 a.m. - 7 p.m.
- Requires advance reservations
- Curb-to-curb
- Fares vary by time & distance
- Trips are constrained by supply and are not guaranteed.

Fairview Lakes Medical Center- Transit Link- Washington County Pilot





The Plan:

Fairview Lakes Medical Center:

- Flex and aggregate appointments for Forest Lake patients, Wednesdays- Thursdays, 10:30 – 1:30 pm

Metro Council- Transit Link

- Cross into Chisago County
- Through aggregation, increases likelihood of trips for Forest Lake patients

Washington County

- Increase awareness of the pilot through one-on-one and small group engagement of Forest Lake residents



Anticipated Outcomes

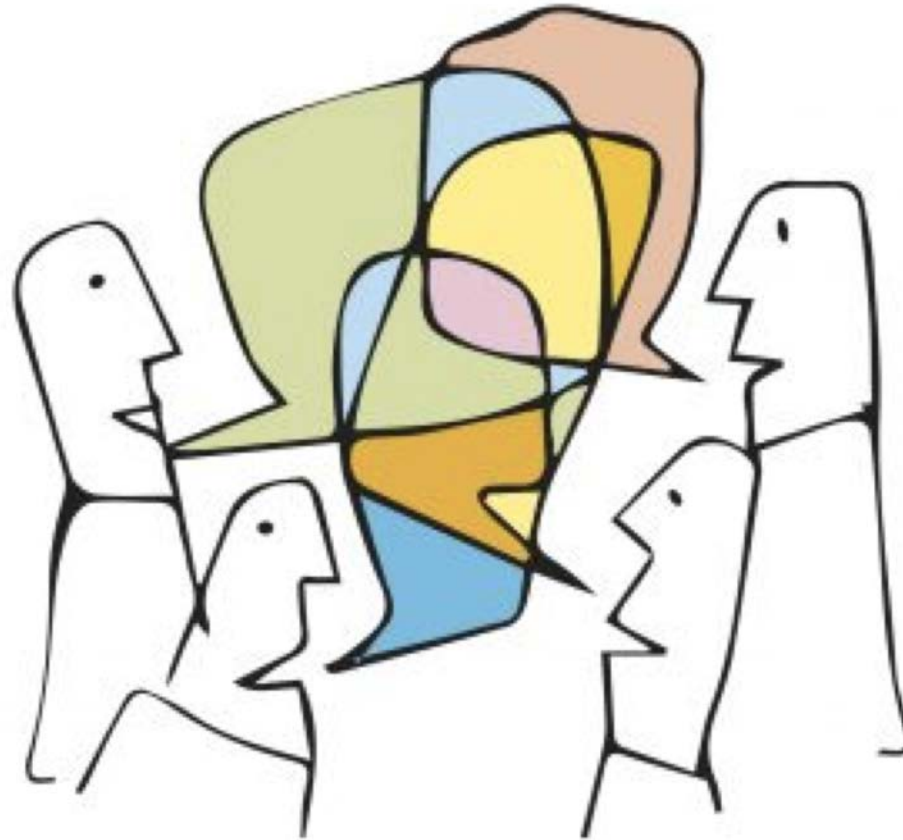
- Reduction in missed appointments
